### **Northern Territory Seniors Card**



The Northern Territory Seniors Card Program offers discounts at participating businesses in the NT and interstate.

The NT Seniors Card is available to all permanent residents of the NT who are 60 years of age or older.

All Seniors Card holders are entitled to free travel on the public bus networks in Darwin and Alice Springs.

NT Seniors Card holders also receive a \$55 discount on the annual registration of their private motor vehicle.

#### Who administers this?

The Seniors Card Program is an Australia wide program managed by each State and Territory.

COTA NT administers the NT Seniors Card program on behalf of the NT Government.

### **NT Concession Scheme (NTCS)**



The NT Concession Scheme (NTCS) provides concessions on a range of essential goods and services to help with living expenses.

Concessions are provided on electricity, water and sewerage, council rates, garbage services, vehicle registration, spectacles and free NT driver licence renewal.

To be eligible, you must be a resident of the NT, an Australia citizen or permanent resident and live in the NT for 183 days (more than half of the year) and in receipt of an eligible Commonwealth benefit from Services Australia (Centrelink) or Veteran Affairs. This includes Aged Pension, Disability Support Pension, Single Parenting Payment, Carer Payment and some DVA benefit recipients and card holders.

#### Who administers this?

Previously known as the NT Pensioner and Carer Concession Scheme, the NTCS is administered by The Department of Territory Families, Housing and Communities through the NT Concession and Recognition Unit.

## **NT Seniors Recognition Scheme (NTSRS)**



The NT Seniors Recognition Scheme (NTSRS) recognises the valuable contribution senior Territorians aged 65 years and older make to our community.

If you are a NT resident aged 65 or over, you may be eligible for the NT Seniors Recognition Scheme.

As a member, you get a \$500 prepaid Visa card each financial year to spend on:

- travel and accommodation
- fuel
- phone and internet services
- utility services electricity, water, sewerage and gas. You can also pay your utility bills at Australia Post outlets that are post Billpay enabled.

#### Who administers this?

The NTSRS is administered by the Department of Territory Families, Housing and Communities through the NT Concession and Recognition Unit.
